## Section 2 – Hazard(s) identification

Classified as Dangerous Goods.

- Flammable Liquid

**Classification** - Category 2 **Signal Word** - Danger

#### **Hazard Statements**

Avoid breathing spray.

Causes eye irritation.

May cause drowsiness or dizziness.

#### **Precautionary Statements**

#### Prevention

Highly Flammable liquid and vapour.

Keep away from open flames.

Avoid breathing spray.

In case of fire: Use alcohol resistant foam or fine water spray for extinction.

Do not eat, drink or smoke when using this product.

Do not breathe vapors.

Use in a well-ventilated area.

#### Response

In case of fire: Use dry chemical, CO2, water spray or fire fighting foam to extinguish.

NOT induce vomiting. Rinse mouth.

If in eye: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

If skin or eye irritation persists, get medical attention.

If inhaled: Remove person to fresh air and keep comfortable for breathing.

Get medical attention if you feel unwell.

#### Section 3 - Composition and information on ingredients

Volatile component by weight:

- Isopropyl Alcohol 55 – 65% CAS# 67-63-0

Other components by weight:

- Solids 15 - 35% - Gum Rosin 20 - 30%

All ingredients are cosmetic grade.

Low viscosity ('ADHESIVE') and high viscosity ('ADHESIVE X') versions.

#### Section 4 - First-aid measures

Isopropyl Alcohol and Ethyl Alcohols are generally considered safe solvents. This is a cosmetic product manufactured for skin application, and presents no major danger especially in the small quantities used.

**Swallowed:** Rinse mouth with water. Do NOT induce vomiting. Give lots of water to drink.

Never give anything by mouth to an unconscious person. Get medical attention if you feel unwell.

For ingestion of large quantities, send patient immediately to hospital. Doctor: gastric lavage.

**Eyes:** Immediately flush with plenty of water. Seek medical attention promptly should irritation persists or loss of vision occur.

**Skin**: Products are formulated for skin contact, but should spillage occur, immediately remove contaminated clothing and wipe skin clean. Wash skin with oily cleansers intended for such purpose and rinse with water. Launder contaminated clothing before re-use.

**Inhaled:** Persons inhaling vapour may exhibit signs of respiratory irritation, dizziness, nausea or headache. Remove promptly to fresh air and seek immediate medical attention. Treat unconsciousness by placing the person in the coma position. Apply artificial respiration if breathing stops.

**First Aid Facilities:** Safety showers, eye wash stations and First Aid kits.

Advice to Doctor: Treat symptomatically.

#### Section 5 - Fire-fighting measures

Suitable Extinguishing Media: Alcohol resistant foam is preferred, but a fine water spray can be used.

Water fog, fine water spray, dry chemical or carbon dioxide may also be used.

**Specific Hazards:** Burning can produce carbon monoxide and/or carbon dioxide.

**Special protective precautions and equipment for Fire Fighters:** Highly flammable liquid. Contain spill. Full fire kit and breathing apparatus is required.

#### Section 6 - Accidental release measures

**Personal Precautions:** Ventilate area.

**Environmental Precautions:** Using gloves, contain spill with absorbent materials and collect for disposal. **Disposal Method:** Disposal by methods as permitted by local authority guidelines. Do not empty into drain.

#### Section 7 - Handling and storage, including how the chemical may be safely used

**Handling:** Vapour is heavier than air and may travel along the ground: distant ignition is possible. Use in well ventilated area, away from source of ignition. Do not eat, drink or smoke whilst using.

Storage: Store in tightly closed containers in a cool dry place abiding by all local precautions required for handling a flammable liquid. Do not smoke in storage area.

#### Section 8 - Exposure controls and personal protection

Avoid eye contact. Emergency eye wash and safety showers should be available in the vicinity of use. Provide adequate ventilation during use. Wash hands before and after use. Remove and launder contaminated clothing. Do not eat, drink or smoke in areas of use.

Odour: Alcohol odour. pH: No Data Available.

**Boiling Point:** 78° Celsius.

Flash point: 12° Celsius (Abel closed cup method ).

#### Section 10 - Stability and reactivity

#### Section 11 - Toxicological information

**Effects: Acute** 

**Swallowed:** Accidental swallowing is unlikely in the industrial setting.

**Eyes:** Vapours may irritate the eyes. Liquid and mists may severely irritate or damage the eyes.

**Skin:** Contact with skin may result in irritation and redness.

**Inhaled:** Vapour is moderately irritating to mucous membranes and respiratory tract.

**Effects: Chronic**.

Long term exposure or heavy contamination may cause, dermatitis, and swelling. This may lead to secondary infection. Deliberate inhalation of the vapour is a known occupational risk.
